

# Invitation

## Open Central European Cup 2024 Salzburg - Rif

1. **Organizing federation:** TSVÖ – Austrian Divers Federation

2. **Time and place of the tournament:**

The tournament will take place from Friday, 20 September 2024 to Sunday, 22 September 2024 at University sports Center Salzburg - Rif,  
Hartmannweg 4, 5400 Hallein

Pool opens friday at: 11.00  
Team leaders meeting: 11.30  
First game friday starts: 12.00  
(maybe earlier, depending on the number of participating teams)

Last game of the day starts: 21.00  
First game Saturday starts: 09.00  
Last game of the day starts: 21.00  
First game Sunday starts: 09.00  
Last game of the day starts: 17.00

3. **Playing area**

The games will be held in a pool that is closed on three of its four sides and evenly deep.

Pool dimensions: 12,5m by 8,5m  
Depth: 3,80m  
Temperature: around 26°C

The changing lane is marked by a rope and measures 2 meters.

4. **Rules, playing times, timetable:**

All International CMAS UWR rules and regulations are valid for this tournament.

5. **Playing modality:**

Up to 10 male and 8 female teams can participate. The draw for positions in the timetable will be held one week before the tournament.

6. **Referees:**

Head referee of the tournament will be Julia Braunegg.  
A team of national and international referees will conduct the games.  
Their costs are covered by the participation fees.  
The organizing federation will provide scuba diving equipment (tanks, regulator and weight belts).

7. **Teams:**  
Only national teams are authorized to participate.  
Senior- (adult), under 24- and under 21 national teams are welcome.  
A team can register up to 20 players to participate in the tournament. Every registered player must be authorized to start for this country, according to CMAS rules. **NO CMAS LICENCES NEEDED.**  
The tournament is not an CMAS Event.
8. **Protests:**  
Protests have to be announced verbally as soon as the reason becomes known by the team captain to the head referee. At the latest, 30 minutes after the game, the protest has to be submitted to the administration in writing, and including a protest fee of 50 €. The administration takes a final, binding decision which cannot be appealed. If the protest is rejected, protest fees are forfeit.
9. **Tournament administration:**  
Tournament administration is composed of a member of TSVÖ and two players from the participating teams and two referees. The administration members will be selected at the team leaders meeting.
10. **Awards:**  
All participating teams will receive a certificate.
12. **Tournament fees:**  
All teams must pay the starting fee of 700,00 € by bank transfer to the organizing federation,
